*Non-Voting Membership types require full payment of annual dues. No stock purchase or initiation fee is required. Non-Voting Memberships end December 31<sup>st</sup> of year purchased. All above membership types allowed to charge to their account for beverage, food, or pro shop purchases. Non-Voting members will be required to keep an active Credit Card on file and will be billed monthly for those charges. Non-Voting membership types are not exempt from special assessments.*
